If a vacuum cleaner is used, the motor must be rated as dust explosion proof. Potential for very fine particles to be taken into the vacuum only to be passed back into the environment due to pore size in the bag or filter.
<b>Methods for cleaning up</b>	Take up mechanically, placing in appropriate containers for disposal.
<b>Prevention of secondary hazards</b>	Clean contaminated objects and areas thoroughly observing environmental regulations.
